ELIGIBILITY

You must meet ALL of the following criteria for the duration of your mobility program membership:

- I do not drive and/or park at the Coral Gables campus nor do I park under the Metrorail station or at any University owned or leased parking lot.
I do not live in on-campus housing.

I am actively employed full-time at the Coral Gables campus or Gables One Tower.

I will be commuting to UM Coral Gables campus or Gables One Tower for the duration of my mobility program membership.

I am not an evening or night shift employee.

I understand that parking on campus without a permit is only permitted during Winter, Spring, and Summer break and that my vehicle tag must be registered with P&T.

My primary commute is to Coral Gables campus or GOT.

I understand that if I intentionally give false information to obtain membership in the Mobility Program, I may lose my privilege to receive any transportation benefits from the University of Miami.

DAILY PARKING PASSES

I understand that as a member of the mobility program I will receive 8 daily parking passes only upon returning my parking permit.

I understand that if i do not return a parking permit I do not receive the daily parking passes.

I understand that if I already use other mobility options I am only eligible to park during the mentioned breaks.

I understand that as a Telecommuter I receive 12 daily parking passes.

I understand that I am responsible for contacting Parking and Transportation to obtain the daily passes.
